### **Historical/Biographical Notes**

The Smith Family and the Wesson (Weston) Family were among the earliest residents of Lincoln, and members of each family were active in local affairs. Both Stephen and Zechariah Wesson (or Weston) served as Treasurer of the Second Precinct in the 1740s and 1750s and in official capacities in the Town of Lincoln after its incorporation in 1754. Other family members were involved in local government into the 19th century. Charles Sumner Smith, 1857-1927, was elected a member of the Massachusetts Senate, was one of the Lincoln Selectmen for many years and was instrumental in the development of Sandy Pond as the Lincoln water supply. Sumner Smith, Charles' son, was also a member of the Board of Selectmen for many years. Charles Sumner Smith married Mary Isabel Smythe, who was descended from the Wesson (Weston) family. The Smith and Weston families lived on Sandy Pond Road during the late 19th-early 20th century. In later years Sumner Smith bought the former Weston property to enlarge his own holdings near Sandy Pond.

### **Scope and Content**

Wesson (or Weston) Family documents include promissory notes, indentures, receipts, letters, deeds, accounts, contracts and agreements, and other family records from 1725 to 1871, and some Second Precinct financial records during the period that Stephen and later Zechariah Wesson (or Weston) served as Treasurer.

Smith Family documents include warranty and quitclaim deeds, mortgage deeds, foreclosings, bills and receipts, wills, inventories, and other papers from 1783 to 1960s.

The collection is arranged chronologically by family.
